- All shipments must be consigned „FREIGHT PREPAID / FREE ARRIVAL“!
- Any shipment arriving outside of our deadlines will be subject to a surcharge of 25 % on our tariff !
- Please provide us, as soon the shipping details are known (latest 2 days prior arrival), a PREADVISE including all relevant informations !
(bill of lading, airwaybill, combined invoice / packing list, etc.)

STORAGE OF EMPTY PACKAGINGS

All empty packaging materials which must be stored during the exhibition must be labeled with our “empty labels”. Unless otherwise agreed all packages carrying this label are considered as empty. No responsibility can be carried for goods left inside. For insurance and security reasons the storage of empty packaging materials on or behind the booths as well as in and around the halls, is prohibited.

PAYMENT

WE WISH TO DRAW YOUR ATTENTION TO THE FACT THAT ACCORDING TO ART.23 OF THE ADSP THE LIABILITY OF THE FREIGHT FORWARDER FOR LOSS AND/OR DAMAGE TO GOODS IS LIMITED IN NORMAL CASES TO 10 EURO/KG OF THE GROSS WEIGHT OF THE CONSIGNMENT AND THAT FOR A CONTRACT ON MULTIMODAL TRANSIT AS WELL AS FOR MAYOR LOSSES A FURTHER LIMIT OF 2 SPECIAL DRAWING RIGHTS/KG RESPECTIVELY EURO 1 MIO EACH OCCURRENCE OR EURO 2 MIO FOR ALL CLAIMS IN AGGREGATE IN CONNECTION WITH THE SAME OCCURRENCE - WHICHEVER IS HIGHER - APPLIES.
